 - a. **RRS 29.2** General Recall is modified to allow the race committee to use any amount of time it wishes after the lowering of the general recall flag before resuming racing operations.
- 2. Eligibility: The regatta is open to all J24 boats and their current registered J 24 Class Skippers.
